



AFFIDAVIT OF TRUTH  
CONCERNING RESPONDENTS' LAWFUL INVOCATION OF THEIR 5<sup>TH</sup>  
AMENDMENT RIGHTS, AND THE PRA  
(PAPERWORK REDUCTION ACT) AS A COMPLETE DEFENSE AND BAR  
TO THIS MALICIOUS AND FRIVOLOUS 'OUTLAW' ACTION

Comes now Sovereign [REDACTED], by through and with  
her husband, counsel, and Attorney In Fact, [REDACTED] (an "indispensable" Party  
in the Community Property [REDACTED] Republic), by birth *non-taxpayers*, free persons

appearing specially and not generally, to enter into evidence the 1<sup>st</sup> and last pages of a “United States 2007 Census of Agriculture” form (form # 07-A0203), which illustrate the COMPLETE compliance, respect, and adhesion to the letter and rule of law by a de-jure government agency, the US Census Bureau, in stark contrast to the de-facto IRS and its’ minions of international and domestic scofflaws.

#### THE ATTACHED EXHIBITS

1. On the top of page 1 of the above referenced Census form (Exhibit “US Census #1”) is printed the following;

*“OMB No. 0535-0226: Approval Expires 07/31/09”* [italics added]

2. On the bottom of the last page of the above referenced Census form (Exhibit “US Census #2) is printed the following statement;

*“According to the Paperwork Reduction Act of 1995, no persons are required to respond to a collection of information unless it displays a VALID OMB number...”* [Italics, EMPHASIS added]

3. The IRS “summonses” that are the basis for this entire malicious and frivolous action contain No OMB number whatsoever, much less a VALID one.

Confer at; TITLE 44 > CHAPTER 35 > SUBCHAPTER I > § 3512

#### § 3512. Public protection

(a) Notwithstanding any other provision of law, no person shall be subject to any penalty for failing to comply with a collection of information that is subject to this subchapter if —

(1) the collection of information does not display a valid control number assigned by the Director in accordance with this subchapter; or

(2) the agency fails to inform the person who is to respond to the collection of information that such person is not required to respond to the collection of

information unless it displays a valid control number.

(b) The protection provided by this section may be raised in the form of a complete defense, bar, or otherwise at any time during the agency administrative process or judicial action applicable thereto.

[End excerpt] [Emphasis added]

4. In addition to the numerous U.S. Supreme Court decisions and precedent cited in their pleadings, Respondents again invoke and rely upon the following U.S. Supreme Court decisions;

Dole v. Steelworkers 494 U.S. 26 (1990) at page 40, in which the court held (in part) that...

“the [Paperwork Reduction] Act ‘allows’ the public, by refusing to answer the [information collection requests] to help control ‘outlaw forms’...”

“And if the doctrine of stare decisis has any meaning at all, it requires that people in their everyday affairs be able to rely on our decisions and not be needlessly penalized for such reliance. Cf. Flood v. Kuhn, 407 U.S. 258, 283 (1972); Wallace v. M’Connell, 13 Pet. 136, 150 (1839).” [from U.S. v. Mason 412 U.S. 391, 399-400 (1973)] [Emphasis added]

5. It is incomprehensible to Respondents how the U.S. Department of Justice [*sic*], and the de-facto government agency “IRS” and a “court” of the United States of America can ignore U.S. Supreme Court precedent<sup>1</sup>, and disregard the letter of the law, specifically the PRA (codified as 44 USC 3500-3520) and the Constitutions of the [REDACTED] Republic and the U.S. of A.

6. As per Dole supra, the IRS’ ‘summonses’ are OUTLAW forms, therefore this ‘action’ to ‘enforce them an ‘outlaw’ proceeding.

“He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his assent to their acts of pretended legislation.” --Declaration of Independence

7. It has become obvious to Respondents that the letter and the rule of the law lack any meaning to these "government" agencies, and this entire frivolous action is "a sham proceeding designed to provide legal cover"<sup>2</sup> to the outlaw a.k.a.unlawful activities of said "agencies" and departments.

"We are fast approaching the stage of the ultimate inversion: the stage where the government is free to do anything it pleases, while the citizens may act only by permission; which is the stage of the darkest periods of human history, the stage of rule by brute force." -- Ayn Rand in "The Nature of Government"

8. Respondents again rely on the protections afforded them by [REDACTED] and United States of America Constitutions and Bill(s) Of Rights, and the PRA, and here again assert their right to BAR these 'outlaw' proceedings immediately, as per the letter of the law.

"Once a government is committed to the principle of silencing the voice of opposition, it has only one way to go, and that is down the path of increasingly repressive measures, until it becomes a source of terror to all its citizens and creates a country where everyone lives in fear." - President Harry S. Truman.

WHEREFORE this "outlaw" and malicious action should immediately be dismissed with prejudice as a matter of law.

IN REGARDS TO THE THREAT OF "SANCTIONS"

- 9. Should Respondents'...
  - a. continued exercise of their God-given and un-alienable Due Process rights to defend themselves by any legal means available against various 'outlaw' forms and agencies that ignore their own laws, and;

- b. continued and unwavering reliance upon numerous U.S. Supreme Court decisions and precedent, and upon the letter and rule of the law as the basis and only means of their defense...

be deemed 'frivolous' by this tribunal, it will come as no surprise, for they have been warned that sanctions will be imposed if they continue to try to defend themselves against these outlaw proceedings.

10. Respondents have resigned themselves to expecting these ongoing tactics consisting of malicious prosecutions, witness intimidation, coercion, duress, infliction of emotional distress, blatant attempts at perjury and subornation, extortion using the US Mail, void judgments and orders executed by un-credentialed "judges," threats of 'sanctions', property theft, and attempts to extract greater sums from Respondents than are authorized by law...all of this from our own fully *Corporatized Justice Department* that ignores its' own, and international law, and that has set back the rights of human beings 1000 years or more by its condoning the barbaric practices of waging unprovoked wars and human torture, excuse me, "enhanced interrogation." Why should this government and its' tribunals, that provide legal-cover for its 'justice' departments and de-facto collections agencies, treat its' Nationals any differently? Confer at;






