AN OPEN LETTER TO CUBA Author: "The Man Who Poked the IRS in the Eye and Won"

Congratulations y Salud Presidente Raul, y Fidel, et al;

You have finally been invited to join one of the world's most exclusive clubs! As you will soon find but, you will profit greatly from this club if you quickly adhere to the US's foreign policy. Los Bankeros control everything. See the following June 25, 1863 confidential communiqué sent from the Rothschild's investment house to a banking firm in NYC, which succinctly summarizes our banking system...

"The few who understand the system will either be so interested in its profits or so dependent upon its favors that there will be no opposition from that class while, on the other hand, the great body of people, mentally incapable of comprehending... will bear its burdens [austerity programs] without complaint..." (--Quoted by **Robert L. Owen** in "<u>National Economy and the Banking System</u>, Washington DC U.S. Govt. Printing Office, 1939, pgs. 99-100. See also pg. 389 in **G. Edward Griffin's** "<u>The Creature From Jeykll Island".</u>)

(This sheds light on how our Congress-Critters who enter Congress as folks of modest means, emerge from Congress and retire as multi-millionaires!)

You see, Sr.'s Castro, about a hundred years ago, our elected Congress-Critters gave away their Constitutionally mandated duty to control our currency to Los Bankeros. As a result, our current dollar is now worth about one-cent in 1913 dollars.

Los Bankeros can create, out of nothing, a billion dollars simply by pressing a key on a computer!! Make no mistake, neither you nor I are allowed do this, but they are allowed to do this all day long, and your bankers will be able to do this too if you "follow orders". Here's how it works...

"The modern banking system manufactures money out of nothing. The process is perhaps the most astounding piece of sleight of hand that was ever invented. And, a most amazing truth...

"Give me control over a nation's currency and I care not who makes its laws." Baron M.A. Rothschild.

You might be pleasantly surprised to learn how much our governments now have in common, and how far we have come in implementing the "Ten Planks" of the <u>Communist Manifesto</u>. As Mr. T. Coleman Andrews (Commissioner of the IRS for 33 months Under the Eisenhower Administration before he resigned) remarked on May 25, 1956 in a <u>U.S. News and World Report</u> article...

...."We're confiscating property now....That's socialism. It's written into the Communist Manifesto. Maybe we ought to see that every person who gets a tax return receives a copy of the Communist Manifesto with it so he can see what's happening to him."

President James A. Garfield (1831-1881) had this to say on the topic...

"While boasting of our noble deeds, we are careful to control the ugly fact that by an iniquitous money system, we have nationalized a system of oppression which, though more refined, is not less cruel than the old system of chattel slavery."

We have come a long way since 1956. Marx, Stalin, and Lenin would be most proud of the new "economic slavery" that the United (Socialist) States of America has perfected.

For example, your police will be shown how to rob your people of every thing they have at a simple traffic stop. That's courtesy of our new "asset forfeiture" laws. Yes, if folks have some cash, or they are driving a nice car, your police will "legally" be able take it from them right there on the street, and then sell it, and/or spend the money on more guns and hollow-point bullets to shoot the people with if they don't "follow orders".

In these "codes", "state" doesn't mean "state" and "income" doesn't mean "income". For example, when the Alaskan "territory" became a "state", the word "Alaska" had to be removed from all our country's "codes" that defined the word "state".

You will have your people in a "state" of total confusion when you do away with the common (sense) law and "codify" everything. And then you mandate that "... the citizen is presumed to know the law".

These "code-writers" are Los Bankero's "language" experts... and they can show you how legalize anything!

For example, over the last 50 years or so, the war profiteers and Los Bankeros have combined together with our government (Mussolini defined this as fascism) to set back the basic rights of human beings to about the 9th century!

(January 15, 1984 report by the **Grace Commission** of President Reagan's Administration.)

Yes, Los Bankeros get it all... as interest... on money they created out of thin air, and then loaned to our government!! As William Casey, former CIA Director, said at his first staff meeting in 1981...

"We'll know our disinformation program is complete when everything the American public believes is false."
